Strange, But True Cases of Veterinary Law, **continued from page 33**

The Superior Court of New Jersey held the defendant liable for the entire veterinary bill of \$851, together with the pre-judgment interest. In doing so, it thus held the defendant responsible for all fees, whether routine or complication-related, that occurred due to the pregnancy.

This determination turned upon a legal concept called "proximate cause," which itself is grounded upon the idea of "reasonable foreseeability." The court here ruled that the defendant's conduct was ultimately responsible for *all* of the events in question: while "the impregnation of the plaintiff's dog was a reasonably foreseeable consequence of the defendant's negligent control of his pet."³ "The exact harm caused by the impregnation did not have to be foreseeable."⁴ Thus,

the court essentially said that the defendant was responsible for all of the veterinary bills because it was reasonably foreseeable for him to know that a pregnancy could occur due to his negligent restraint of his pet and that, with such a medical condition, come the possibility of some form of complications, the exact nature of which he was not charged with being able to predict.
