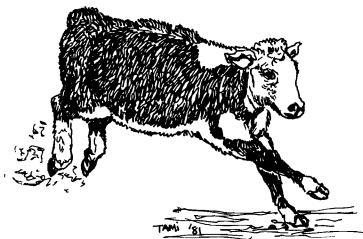
After three years of service in the Veterinary Corps, **Dr. C. D. Sours** worked in a large animal practice in Nora Springs, IA.

Disease Management of the Nursing Pig

Date: May 20–21, 1981
