### ANTIBIOTICS

Of the more than 300 antibiotics reported in the last ten years only five have attained the stature of chemotherapeutic agents.

Most surgeons now agree that antiseptics have no place in the treatment of surgical wounds.

### RUMEN TRANSPLANTS

Transfer of rumen fluids deserves therapeutic rank with, and warrants simultaneous use with calcium gluconate, sulfonamides, and the antibiotics.

The new drug, called Tryptar, developed by Armour Laboratories, Chicago, Illinois, has been used with much success on third-degree burns. It is made from the enzyme trypsin.

Semen taken from the seminal vesicles of a bull immediately after being killed and used for artificial insemination resulted in a conception rate of 71 percent.
