

# Iowa State University Veterinary Medical Alumni Association Annual Meeting

The annual meeting of the Iowa State University Veterinary Medical Alumni Association (ISUVMAA) was held at the Marriott Hotel, Des Moines at noon on January 28, 1996. There were 49 members in attendance.

President Jane Lau-Collison called the meeting to order and turned the podium over to Dr. Nolan Hartwig, secretary and treasurer, who made several introductions. As motion was made, seconded and passed that the 1995 minutes be approved as circulated.

Dr. Hartwig asked for approval of the printed treasurer's report. Dr. Anthony made a motion that \$1,000.00 be allocated to the ISU Athletic Department. Dr. Drappen seconded the motion. Following discussion the motion was defeated. A motion was made, seconded and passed that the treasurer's report stand as presented. Dr. Hartwig discussed the proposed 1996 budget. She showed a copy of the *Veterinary Handbook*, which the senior class president stated was the choice of the graduating class. A bookplate with a short mission statement of the ISUVMAA will be adhered to each book and presented to the class of 1996. Several members commented on alternative ways for purchasing or acquiring these books. Dr. Hartwig moved that the proposed budget for 1996 as presented be approved with the added comment that the board would investigate the possibility or availability of manufacturer's support for this project. The membership approved the motion.

The membership elected Dr. Don Fick from Muscatine as the new board member for the ISUVMAA.

The following slate of officers were presented by the Board of the ISUVMAA and elected by the membership for 1996: Dr. Gene Warren, president; Dr. Matt Sexton, vice-president; and Dr. Darrell Trampel, secretary and treasurer.

Dean Ross commented on the importance of the various alumni receptions that are sponsored by the ISUVMAA and thanked Joan Kluge and Dr. Hartwig for their involvement with the association.

Dr. Gary Osweiler shared with the membership what the Healthy Livestock Initiative (HLI) has provided for the ISU Diagnostic Laboratory. Dr. Chris Brown related some changes that have taken place in ISU Clinical Sciences from the available HLI funds. Last year, \$1 million was generated for the HLI and an additional \$2 million is needed this year. Dean Ross is working with the IVMA leadership and the Iowa Legislature to attain this goal.

Dean Ross informed the membership that there would be a celebration for the announcement of Dr. Harley Moon as the recipient of the Ramsey Chair.

Dr. Lau-Collison felt that we have a progressive association and asked that any ideas, comments or concerns be presented to any board member. The meeting was turned over to Dr. Warren who thanked Dr. Hartwig for his many years of dedicated service as Secretary and Treasurer of the Iowa State University Veterinary Medical Alumni Association.

No new business was initiated and the meeting was adjourned.
