

ENHANCED ACCESS MASTER AGREEMENT

Agreement dated as of January 1, 2021 (the “Agreement”) between John Wiley & Sons, Inc., a New York corporation, 111 River Street, Hoboken, New Jersey 07030 (“Wiley US”, and with its affiliates Wiley Periodicals LLC, John Wiley & Sons, Ltd, John Wiley & Sons Australia, Ltd, John Wiley & Sons A/S and Wiley-VCH GmbH (“Wiley Affiliates”), collectively “Wiley”), and Iowa State University, 701 Morrill Road, Ames, IA 50011-2142 (the “Customer”).

1. DEFINITIONS

The following terms shall be deemed to have the meaning as set forth below:

- 1.1. **Account Discount** - means the discount on the APC based on the size of the Advance Payment if any;
- 1.2. **Accepted Articles** – primary research and review articles that have been accepted for publication in a Wiley Gold or Hybrid Journal by Corresponding Authors who are authorized by the Customer to submit the article to Wiley for publishing under the terms of this Agreement.
- 1.3. **Advance Payment** - means the amount a Customer pays in advance to cover the APCs published by Authorized Users, if applicable;
- 1.4. **Agreement** – This Agreement between Wiley and the Customer that sets out the terms and conditions under which Wiley will provide the Customer with access to the Electronic Products and Services subscribed to by the Customer as specified in the Appendices and Schedules signed by the parties, which are incorporated herein by reference. Each of such Appendices and Schedules is governed by the terms of this Agreement. In the event of any conflict between the terms of an Appendix, Schedule, or any Invoice Agreement Letter (or a written equivalent thereof), on the one hand and the terms of this Agreement on the other hand, the terms of the Appendix, Schedule, Invoice Agreement Letter (or written equivalent thereof) will govern.
- 1.5. **Article Publication Charge - (APC)** means the charge levied by Wiley on the acceptance of primary research material and review articles for publication in Gold or Hybrid Journals, the amount of which is dependent on the publication in which such material is published, and the negotiated fee specified herein;
- 1.6. **Authorized Users** –Those persons who are authorized by the Customer to have access to the Licensed Electronic Products. Authorized Users must be:
 - 1.6.a. current full- and part-time faculty members, students, researchers, staff members, librarians, scientific staff, other executives or employees of the Customer, or
 - 1.6.b. contractors engaged by the Customer, provided such contractors have been informed of, and agree to abide by, the Terms and Conditions of Use set forth herein and they access Wiley Online Library (or other platforms designated by Wiley) and the Electronic Products via the Customer’s Secure Network.
 - 1.6.c. Patrons not affiliated with the Customer, who are physically present at Customer’s site(s) (“Walk-ins”) and using the Customer’s authentication methods and parameters to access the Licensed electronic Products through the Customer’s Secure Network.

- 1.7. **Commercial Use** –Use for the purposes of monetary reward by means of sale or resale. For the avoidance of doubt, charging administrative fees to cover the costs of making permitted copies is not prohibited. Use by the Customer, or by an Authorized User of the Electronic Products in the course of research funded by a commercial organization, is not Commercial Use.
- 1.8. **Corresponding Author** - Authorized User (excluding contractors and Walk-in-Users) 1.8.a. who is responsible for manuscript submission, correction, proof reading, whole correspondence during the paper submission, handling the revisions and re-submission of revised manuscripts up to the acceptance of the manuscripts by Wiley, provided, however, the author may not have undertaken all such article administration tasks, one or more of which may have been delegated,
- 1.8.b. who is named as the Corresponding Author on the final published article, and
- 1.8.c. whose affiliation with the Customer has been verified according to the internal control procedures of the Customer.
- 1.9. **Customer** –The customer named above, as further defined in Schedule 1, which has authorized the signing of this Agreement, provides access via its Secure Network for its Authorized Users as defined in this Agreement, and is responsible for the payments specified in the attached Appendices and for the implementation of the Agreement. Schedule 1 will include information on the specific authentication method and valid parameters for the Secure Network which are covered by this Agreement.
- 1.10. **Electronic Products** - All products, services and content available in Wiley Online Library (or other platforms designated by Wiley) shall be deemed included within the definition of Electronic Products. Details specific to the type of electronic products or services licensed hereunder as well as pricing and the Customer’s access rights are provided in the appropriate Appendix. These products and services are defined as follows:
- 1.11. **Licensed Electronic Products** - The electronic (online) editions of Wiley journals and other publications and the content therein, including but not limited to major reference works, Current Protocols laboratory manuals and databases which the Customer has licensed hereunder as specified herein and in the appropriate Appendices.

- 1.11.a. **Licensed Electronic Services** – The electronic features and services in Wiley Online Library (or other platforms designated by Wiley) available to the Customer and its Authorized Users, as follows.
- 1.11.a.i. *EarlyView* – publishes peer reviewed, fully citable articles online as soon as they are ready, before the release of the compiled journal issue.
- 1.11.a.ii. *Saved Title Alerts* – allows Authorized Users to request and receive via e-mail the tables of contents from any of the journals available online in Wiley Online Library (or other platforms designated by Wiley) and to receive notification of articles newly published which match specified search criteria.
- 11.1. **Hybrid Journals:** Subscription journals published by Wiley that also offer authors the option to publish papers on an open access basis listed at <https://authorservices.wiley.com/asset/WileyJournal-APCs-OnlineOpen.xlsx>. Wiley may change the URL at its sole discretion.
- 11.2. **Gold Journals** – Open access journals published by Wiley that publish all papers on an open access basis listed at <https://authorservices.wiley.com/asset/Wiley-Journal-APCs-OpenAccess.xlsx>. Wiley may change the URL at its sole discretion.
- 1.12. **Intellectual Property Rights** - These rights include, without limitation, patents, trademarks, trade names, design rights, copyright (including rights in computer software), database rights, rights in know-how and other intellectual property rights, in each case whether registered or unregistered, which may subsist anywhere in the world.
- 1.13. **Institutional Account Holder** - means the Customer, an Institution that has a WOAA;
- 1.14. **Institutional Account List** - means the list of Institutional Account Holders Wiley publishes on on <https://authorservices.wiley.com/author-resources/Journal-Authors/licensing-openaccess/openaccess/institutional-funder-payments.html>;
- 1.15. **Secure Network** - The network which provides access to Wiley Online Library (or other platforms designated by Wiley) for Authorized Users via the specific Customer’s authentication method and valid parameters.
- 1.16. **The Site** - means the Internet Site at the URL <https://authorservices.wiley.com/authorresources/Journal-Authors/licensing-open-access/open-access/institutional-funder-payments.html>;
- 1.17. **Wiley Online Library** - The online service (or any successor thereto) available from Wiley including all products, services and features offered via the service. Certain products and services under this Agreement may be delivered from other platforms as noted in the Appendices. The terms and conditions hereof are equally applicable to those products and services.
- 1.18. **WOAA** - means the Wiley Open Access Account held by the Customer for the purposes of administering open access workflows in Wiley’s Hybrid and Gold Journals.

2. **ACCESS AND PUBLICATION PRIVILEGES**

- 2.1. Wiley grants to the Customer and its Authorized Users, during the Term as defined below, a nonexclusive, non-transferable right and license to access, via Wiley Online Library (or other

platforms designated by Wiley), the full text and other material such as datasets published online for the Licensed Electronic Products as listed in the Appendices attached hereto as may be amended from time to time on the Terms and Conditions of Use described below.

- 2.2. Authorized Users will have access to all available tables of contents, article abstracts, chapter summaries and associated websites for all Electronic Products.
- 2.3. The Customer grants access to Wiley Online Library (or other platforms designated by Wiley) only to Authorized Users as defined herein. The number of the Authorized Users who may simultaneously access Wiley Online Library (or other platforms designated by Wiley) is unlimited.
- 2.4. The Customer acknowledges that the Electronic Products, Wiley Online Library, Wiley's other platforms, and the Intellectual Property Rights contained therein are protected by law. All rights not specifically licensed herein to the Customer are expressly reserved by Wiley. The contents of the Licensed Electronic Products are solely for the personal, non-commercial use of the Authorized Users. For this purpose, Commercial Use is defined as in clause 1.7 above.
- 2.5. All Authorized Users are bound by the Terms of Use which are available at <https://onlinelibrary.wiley.com/terms-and-conditions>. Wiley reserves the right to modify such Terms of Use as described therein.
- 2.6. Notwithstanding anything else in the Agreement, Wiley grants to Customer nonexclusive, royalty-free, systemwide perpetual access to electronic files of the specific content that was subscribed to or for which a perpetual license fee has been paid during the term of this Agreement as stated in the specific Appendix and for which Wiley has the rights to deliver.
 - 2.6.a. Such use shall be in accordance with the provisions of this Agreement, which provisions shall survive any termination of this Agreement.
 - 2.6.b. The means by which Customer shall have access to such Licensed Electronic Products shall be in a manner and form substantially equivalent to the means by which access is provided under this Agreement, excluding any enhancements added to the version originally published.
 - 2.6.c. If, in its sole discretion, Wiley decides that it cannot continue providing access in the same manner and form, Wiley will provide an archival copy in the electronic medium selected by Wiley and the Customer, at a reasonable cost-based fee (primarily production and media costs incurred by Wiley) agreed to by both parties, and subject to the security requirements.
 - 2.6.d. Wiley has designated both Portico and CLOCKSS as third-party providers of perpetual access in the Licensed Electronic Products. The Customer may access the Licensed Electronic Products on either Portico's or CLOCKSS' server, or another third-party provider designated by Wiley solely in the event of downtime of Wiley's platform and authorization by Wiley, provided:
 - 2.6.d.i. Wiley continues to designate Portico, CLOCKSS or such third party as a perpetual access provider;
 - 2.6.d.ii. The Licensed Electronic Products are available on Portico, CLOCKSS, or such third party;
 - 2.6.d.iii. Wiley maintains copyright over the Licensed Electronic Products;

2.6.d.iv. Portico's, CLOCKSS' or such third party's procedures for providing access are followed. Such access would be deactivated immediately on resumption of access to Wiley Online Library.

2.7 Wiley grants Corresponding Authors during the Term a non-transferable right to publish Accepted Articles open access ("Publishing Privilege") in Wiley's Hybrid and Gold Open Access Journals subject to payment provided in Schedule 3. For the avoidance of doubt, the Publishing Privilege shall only apply to articles accepted for publication by Wiley during the Term of this Agreement, Corresponding Authors publishing Accepted Articles open access will be required to sign the then current open access publishing agreement provided by Wiley.

3. **TERMS AND CONDITIONS OF USE**

3.1. The rights and restrictions governing access to Wiley Online Library (and other platforms designated by Wiley) and the Electronic Products by the Customer and its Authorized Users are outlined below.

3.1.a. Authorized Users may download, search, retrieve, display and view, copy and save to a Secure Network or other electronic storage media and store or print out single copies of individual articles, chapters or entries in the Licensed Electronic Products for the Authorized User's own personal use, namely scholarly, educational or scientific research or internal business use. Authorized Users may also transmit such material to a third-party colleague in hard copy or electronically, for personal use, namely scholarly, educational, or scientific research or professional use but in no case for re-sale, systematic distribution, e.g. posting on a listserv, network (including distribution through social networking websites and scholarly collaboration networks, except for those that have agreed to Wiley's Article Sharing Policy found here:

<https://onlinelibrary.wiley.com/researchers/toolsresources/article-sharing> and solely in accordance therewith) or automated delivery, or for any other use. In addition, Authorized Users have the right to use, with appropriate credit, figures, tables and brief excerpts from individual articles, chapters or other entries from the Licensed Electronic Products in the Authorized User's own scientific, scholarly and educational works such as books and articles. This right does not extend to use of material, including images or figures that are separately listed as the copyright of a third party.

3.1.b. All Authorized Users have the option to create a My Profile Page, which will allow them to create data files and links to articles, chapters and entries of interest in the Licensed Electronic Products, and search criteria, which may be reused by them. In order to do so, the Authorized User will have to select and register a username and password which the Authorized User must keep confidential and not disclose to or share with anyone else.

3.1.c. The Customer and its Authorized Users may create links to Wiley Online Library (or other platforms designated by Wiley) from their Online Public Access Catalog (OPAC) records, library catalogs, link resolvers, locally hosted databases or library web pages, provided those links are operated by the Customer on a Secure Network, do not result in access to licensed content by anyone other than Authorized Users, and are not used in connection with any paid or commercial service or for any other commercial use whatsoever. Authorized Users may search, view, and browse Licensed Electronic Products using the interface provided by Wiley. Automated searching, robotic searching and decompilation are strictly prohibited.

- 3.1.d. Course Packs (Print and Electronic). Authorized users who are members of the Customer's faculty or staff may use a reasonable portion of the Licensed Electronic Products in the preparation of Course Packs or other educational materials to be distributed to students at the Customer's institution free of charge or at a cost-based fee.
- 3.1.e. Course Reserves (Print and Electronic). Customer and Authorized Users who are members of the Customer's faculty or staff may store in electronic format in secure electronic data files and use a reasonable portion of the Licensed Electronic Products in connection with specific courses of instruction to be access by Authorized Users that who are students at the Customer's institution and access the content using the Customer's Secure Network and parameters.
- 3.1.f. The Customer's library staff may supply a single copy of an individual document, chapter or book derived from the Licensed Content to an Authorized User of another library utilizing the prevailing technology of the day and subject to the security requirements in this Section 3 of the Agreement. Customer agrees to fulfill such requests in compliance with Section 108 of the United States Copyright Law (17 USC 108, "Limitations on exclusive rights: Reproduction by libraries and archives").
- 3.1.g. Authorized Users who wish to text and data mine the Licensed Electronic Products for non-commercial purposes may do so by using the CrossRef Text and Data Mining Service <http://tdmsupport.crossref.org/researchers/> and consenting to Wiley's Text and Data Mining Agreement at <http://olabout.wiley.com/WileyCDA/Section/id-826542.html>.
- 3.2. Except as provided in paragraph 3.1 above or with respect to material published on an open access basis, Authorized Users may not copy, distribute, transmit or otherwise reproduce, sell, or resell material from the Electronic Products; post or store such material in any form or medium in a retrieval system, network or listserv; or transmit such material, directly or indirectly, for use in any paid service such as document delivery or list serve, or for use by any information brokerage or for systematic distribution, whether or not for commercial or non-profit use, or for a fee or free of charge.
- 3.3. The Customer and its Authorized Users may not remove, obscure or modify any copyright or proprietary notices, author attribution or any disclaimer as they appear on Wiley Online Library (or other platforms designated by Wiley) and the Electronic Products. Authorized Users may not integrate material from the Electronic Products with other material or otherwise create derivative works in any medium. However, brief quotations for purposes of comment, criticism or similar scholarly purposes are not prohibited herein.
- 3.4. Authorized Users may not do anything to restrict or inhibit any other Authorized User's access to or use of Wiley Online Library (or other platforms designated by Wiley) and the Licensed Electronic Products.
- 3.5. If an Authorized User fails to abide by these Terms and Conditions of Use or other terms of this Agreement, or the Customer hosts an authentication method and parameters that have been identified as abusive or malicious, Wiley reserves the right in its sole discretion to suspend or terminate access to Wiley Online Library (and other platforms designated by Wiley) and the Licensed Electronic Products by such Authorized User or authentication method and parameters immediately without notice, in addition to any other available remedies. Except in the case of a material breach which Wiley deems dangerous to the integrity and security of Wiley Online Library (or other platforms designated by Wiley), or for a breach which, if not immediately

remedied, is likely in Wiley's opinion to continue to cause damage, Wiley shall give prior written notice to the Customer of its intention to terminate such access and shall allow the Customer and/or the Authorized User as applicable 30 days after receipt of such notice to cure the breach or agree to abide by the terms and conditions of this Agreement. The Customer shall notify Wiley when malicious credentials associated with offending authentication method and parameters have been remediated. Wiley shall immediately restore services upon notification that credentials associated with the abusive or malicious activity have been remediated.

4. FEES AND CHARGES

- 4.1. Fees and other charges for online access to the Licensed Electronic Products by the Customer and its Authorized Users and for the Publishing Privilege, and other services provided by Wiley Online Library (or other platforms designated by Wiley), are specified in Appendices attached hereto, and will be due as set forth in the relevant invoice. Customer is also responsible for any applicable taxes where required by law.
- 4.2. The Customer is responsible for any charges associated with accessing Wiley Online Library (and other platforms designated by Wiley) and the Licensed Electronic Products, including, but not limited to, any computer equipment, telephone or Internet connections and access software.
- 4.3. The Customer is responsible for ensuring that any third party authorized by the Customer to make payments on its behalf shall promptly pay Wiley the full amounts due under this Agreement.
- 4.4. Wiley shall annually send the Customer an Invoice Agreement Letter. Upon the Customer's signature on the Invoice Agreement Letter or written acceptance of fees via email, and payment of fees set forth therein, this Agreement shall apply, or shall renew for the period set forth in the Invoice Agreement Letter. Except as specifically set forth in the Invoice Agreement Letter or written acceptance via email as set forth above, the terms and conditions of this Agreement (including updated Appendices) shall continue to apply.
- 4.5. Wiley may issue the relevant invoice for online access to the Licensed Electronic Products through Wiley US or any of its Wiley Affiliates.

5. MUTUAL OBLIGATIONS

- 5.1. Wiley will:
 - 5.1.a. make commercially reasonable efforts consistent with industry standards to ensure uninterrupted online access to and continuous availability of the Licensed Electronic Products to Authorized Users in accordance with this Agreement, and to restore access to such Licensed Electronic Products as promptly as possible in the event of an interruption or suspension of the Wiley Online Library (or other platforms designated by Wiley) service which is not attributable to any third-party service provider over which Wiley has no control (e.g., an Internet or telecommunications service provider); Wiley's Internet Service and Reliability Letter is incorporated herein as Schedule 4.
 - 5.1.b. use commercially reasonable efforts consistent with industry standards to ensure that Wiley's server or servers have sufficient capacity and rate of connectivity to provide the Customer and its Authorized Users with a quality of service comparable to current standards in the on-line information provision industry.

- 5.1.c. Support. Wiley will offer support to assist Customer and Authorized Users in use of the Licensed Electronic Products and will make its personnel available by email and/or phone during regular business hours, Monday to Friday.
- 5.1.d. provide aggregate usage statistics to the Customer which are compliant with COUNTER Codes of Practice or conform to the then-prevailing industry standard (except as otherwise specified in the attached Appendices) about the use of the Licensed Electronic Products by the Customer's Authorized Users, consistent with applicable privacy laws and confidentiality requirements.
- 5.1.e. Wiley shall make reasonable efforts to comply with the Americans with Disabilities Act (ADA) Section 508 of the Rehabilitation Act Amendments, by supporting assistive software or devices and interfaces/design to aid persons with various sight or hearing impairments such as large-print interfaces, text-to-speech output, refreshable braille displays, voice-activated input, and alternate keyboard or pointer interfaces.
 - 5.1.e.i. Wiley Online Library endeavors to conform to level Double-A of the World Wide Web Consortium (W3C) Web Content Accessibility Guidelines (WCAG) 2.1
 - 5.1.e.ii. Wiley shall make reasonable efforts to ensure that maintenance and upgrades for the Licensed Electronic Products are implemented in a manner that does not compromise product accessibility.
 - 5.1.e.iii. Wiley shall provide the Customer with a current completed Voluntary Product Accessibility Template (VPAT) upon the Customer's request.
 - 5.1.e.iv. In the event that the Licensed Electronic Products are not accessibility compliant Wiley shall make best efforts to:
 - 5.1.e.v. cooperate with the Customer using commercially reasonable efforts to adapt specified Licensed Electronic Products to make them accessible to the extent necessary in order to comply with such applicable law; or
 - 5.1.e.vi. grant Customer the right to adapt, modify or copy portions of the specified Licensed Electronic Products as needed to make them useable to the extent required in order to comply with federal and state law, provided that any adapted Licensed Electronic Products is only made available to Authorized Users for whom such adapted versions were necessary.
- 5.1.f. make available to the Customer, prior to the beginning of the calendar year within the current term, an itemized holdings report that specifies the titles included in the Licensed Electronic Products for the next subscription term. Wiley will use reasonable efforts to update itemized holdings reports as soon as is practicable when holdings information changes, and will provide this information to the Customer on request. Wiley will make available itemized holdings lists for the Licensed Electronic Products in KBARTcompliant format.
- 5.1.g. publish on an open access basis eligible articles submitted by Corresponding Authors, accepted by Wiley, verified by the affiliation, and by Corresponding Authors selecting the open access option in the workflow provided by Wiley, subject to the terms of section 11 and Schedule 3, and payment of the fee outlined in Schedule 3.

5.2. The Customer will:

- 5.2.a. take all reasonable measures to inform Authorized Users of the Terms and Conditions of Use governing access to Wiley Online Library (and other platforms designated by Wiley) and

to emphasize to such Authorized Users the need to comply with whatever restrictions on access, use, reproduction and transmission are included therein;

- 5.2.b. make access available to Authorized Users only through the Customer's Secure Network and using the authentication method and valid parameters on Schedule 1 or other secure authentication methods as described in the appropriate Appendix; undertake reasonable measures within its control to prevent access to and improper use of the Licensed Electronic Products and Wiley Online Library (and other platforms designated by Wiley) by unauthorized persons (including without limitation using the most current patches, regularly scanning the Secure Network for vulnerabilities, and regularly monitoring the proxy logs for unauthorized user access (such as multiple logins using the same id, high volume downloads, and tracking/blocking automated traffic)); and take responsibility for remediating all issues uncovered and for terminating any unauthorized access of which it has actual notice or knowledge;
- 5.2.c. provide Wiley with information about the Customer's specific authentication method and valid parameters which can be used by Wiley to authenticate Authorized Users. The Customer represents that all such authentication method and parameters shall be limited to the Customer's Secure Network and shall be listed in Schedule 1 as updated from time to time. The Customer is responsible for ensuring that all specific authentication method and valid parameters on Schedule 1 or otherwise provided to Wiley correspond with the Customer's valid parameters and are limited to the physical addresses specified in this Agreement.
- 5.2.d. use all reasonable efforts to monitor compliance with the Terms and Conditions of Use and promptly notify Wiley of any copyright infringement or unauthorized usage of the Electronic Products, which comes to the Customer's attention; and cooperate fully with Wiley in the investigation of such infringement or unauthorized use and in any action, which Wiley takes to enforce its copyright and other Intellectual Property Rights, at Wiley's expense. Notwithstanding the above, the Customer will not be responsible for such unauthorized use which is without the express or implied consent of the Customer, provided that the Customer has taken reasonable steps to prevent such misuse and, upon learning of it, uses all reasonable efforts to ensure that such activity ceases, and notifies Wiley promptly of any such breach or infringement.
- 5.2.e. except with respect to material published on an open access basis, neither the Customer nor any Authorized User has the right to incorporate any material from the Electronic Products into any institutional or other repository. Author agreements are separately negotiated with Wiley and include provisions about what authors may and may not do with respect to materials authored by them and published by Wiley (including social networking websites and scholarly collaboration networks, except for those that have agreed to Wiley's Article Sharing Policy found here:
<https://onlinelibrary.wiley.com/researchers/toolsresources/article-sharing>).

6. PRIVACY AND DATA PROTECTION POLICY

- 6.1. If Wiley is compelled by law or court order to disclose personally identifiable information of Authorized Users of patterns of use, Wiley shall provide the Customer with adequate prior written notice as soon as is practicable, so that Customer or Authorized Users may seek protective orders or other remedies. Wiley will notify Customer and Authorized Users as soon as is practicable if

Wiley's systems are breached and the confidentiality of personally identifiable information is compromised.

7. TERM AND TERMINATION

- 7.1. The Term of this Agreement commences on January 1, 2021 and ends on December 31, 2023.
- 7.2. Wiley may terminate access to Wiley Online Library (or other platforms designated by Wiley) by an Authorized User who breaches Wiley's Terms and Conditions of Use or infringes the copyright or other Intellectual Property Rights in the Electronic Products, Wiley Online Library, or any other Wiley platform, and the Customer shall assist Wiley as necessary.
- 7.3. Either party may terminate this Agreement if the other party materially breaches its obligations under this Agreement and fails to cure such material breach, provided that the non-breaching party shall give written notice of its intention to terminate and shall allow the breaching party 60 days after receipt of such notice to remedy the breach.
- 7.4. During the term of each applicable Appendix, the Customer may license additional Electronic Products under such Appendix and this Agreement. If the Term of the Agreement as set forth in paragraph 7.1. is extended, the term of the applicable Appendix will be automatically extended to run concurrently with the Term of this Agreement in order to allow the Customer to continue to license additional products under such Appendix in subsequent years. Notwithstanding anything to the contrary, the Appendix term may never exceed the Term of the Agreement.
- 7.5. Customer is a public institution and this agreement shall in no way or manner be construed so as to bind or obligate the State of Iowa or the University beyond the term of any particular appropriation of funds by the State of Iowa Legislature as may exist from time to time. Customer reserves the right to terminate this Agreement in whole or in part (including cancellation of any portion of the Licensed Products during the Term) if, in its sole judgment, the Legislature of the State of Iowa fails, neglects, or refuses to appropriate sufficient funds as may be required for the University to continue such payments, or requires any return or "give-back" of funds required for the University to continue payments, or if the Executive Branch mandates any cuts or holdbacks in spending. All affected future rights and liabilities of the parties hereto shall thereupon cease within thirty (30) calendar days after notice by Customer. If the Customer executes this option, no refund of payment already received by Wiley will be owed to the Customer. Appropriation is a legislative act and is beyond control of Customer.

8. WARRANTY AND DISCLAIMERS BY WILEY

- 8.1. Wiley represents and warrants that it has the right and authority to make the Licensed Electronic Products available to the Customer and its Authorized Users pursuant to the terms and conditions of this Agreement and that, to the best of Wiley's knowledge, the Licensed Electronic Products do not infringe upon any copyright, patent, trade secret or other proprietary right of any third party.
- 8.2. Wiley Online Library (and other platforms designated by Wiley) and the Electronic Products may provide Authorized Users with links to third-party websites. Where such links exist, Wiley disclaims all responsibility and liability for the content of such third-party websites. Authorized Users assume sole responsibility for the accessing of third-party websites and the use of any content on such websites.
- 8.3. Except for the warranties provided by Wiley in paragraph 8.1 above,

- 8.3.a. WILEY ONLINE LIBRARY, OTHER PLATFORMS DESIGNATED BY WILEY, AND THE ELECTRONIC PRODUCTS AND ALL MATERIALS CONTAINED THEREIN ARE PROVIDED ON AN "AS IS" BASIS, WITHOUT WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF TITLE, OR IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE;
- 8.3.b. THE USE OF THE ELECTRONIC PRODUCTS, WILEY ONLINE LIBRARY, OTHER PLATFORMS DESIGNATED BY WILEY, AND ALL MATERIALS IS AT THE AUTHORIZED USER'S OWN RISK;
- 8.3.c. ACCESS TO WILEY ONLINE LIBRARY, OTHER PLATFORMS DESIGNATED BY WILEY, AND THE ELECTRONIC PRODUCTS MAY BE INTERRUPTED AND MAY NOT BE ERROR FREE; AND
- 8.3.d. NEITHER WILEY NOR ANYONE ELSE INVOLVED IN CREATING, PRODUCING OR DELIVERING WILEY ONLINE LIBRARY, OTHER PLATFORMS DESIGNATED BY WILEY, THE ELECTRONIC PRODUCTS, OR THE MATERIALS CONTAINED IN SUCH PLATFORMS, SHALL BE LIABLE FOR ANY DIRECT, INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL OR PUNITIVE DAMAGES ARISING OUT OF THE AUTHORIZED USER'S USE OF OR INABILITY TO USE WILEY ONLINE LIBRARY, OTHER PLATFORMS DESIGNATED BY WILEY, THE ELECTRONIC PRODUCTS AND ALL MATERIALS CONTAINED THEREIN.
- 8.4. Wiley shall indemnify and hold the Customer harmless from and against any damages, costs and fees (including reasonable attorney's fees) resulting from any judgment against the Customer arising out of the claim of a third party that Wiley's license of the Licensed Electronic Products or the Customer's use thereof constitutes an infringement of any copyright, patent, trade secret or other proprietary right of any such third party. This indemnity shall survive termination of the Agreement for two years. This indemnity shall not apply if the claim involves content which has been modified or used in a manner not permitted under this Agreement or if the Customer has failed to comply with other material terms of this Agreement.
- 8.5. The Customer shall give prompt notice of an infringement claim to Wiley, shall provide such cooperation and assistance to Wiley as is reasonably necessary to defend the claim, and shall allow Wiley to have the sole control of the defense, provided, however, that the Customer retains the right to participate in the defense at its own expense.

9. CONFIDENTIALITY PROVISIONS

- 9.1. The Parties undertake to keep confidential information which has either been marked "confidential" by Wiley or which, by the nature of the circumstances surrounding the disclosure, would be understood to be confidential by a reasonable party, as long as such information has not been lawfully disclosed to the public or independently developed ("Confidential Information") confidential. The Parties undertake and not to disclose to unaffiliated third parties such Confidential Information without the prior written consent of the other disclosing party which will not be unreasonably withheld. Without prejudice to what is required by the legislation in force concerning the transparency of the acts and what is required following a judicial decision or requests from guarantee authorities.

- 9.2. The parties agree as of now that this Agreement and its terms may be made publicly available on the Customer's website, Open APC and in the ESAC Registry of transformative agreements, no earlier than 30 days after the Customer and Wiley have signed the Agreement.

10. GENERAL PROVISIONS

- 10.1. Wiley may assign this Agreement to its successors, subsidiaries or assigns. This Agreement may not be assigned by the Customer except with the prior written consent of Wiley.
- 10.2. In the event of a material breach of the terms and conditions of this Agreement by either party, the non-breaching party will be entitled, in addition to any other remedies available pursuant to this Agreement or at law, to equitable, including injunctive, relief.
- 10.3. Notwithstanding any other term in this Agreement, neither Party's delay or failure to perform any provision of this Agreement due to circumstances beyond its control (including, without limitation, war; civil disorder; strike; flood; fire; storm; accident; terrorism; governmental restriction; infectious disease; epidemic; pandemic; public health emergency; embargo; power, telecommunications or Internet failures; damage to or destruction of any network facilities; the enactment of any law, executive order, or judicial decree; or any other circumstance beyond a Party's control whether similar or dissimilar to the foregoing) ("Force Majeure") will be deemed to be, or to give rise to, a breach of this Agreement. The Party claiming Force Majeure will provide written notice of the circumstances (where possible) and will be entitled to a reasonable extension of time for performing such obligations. Where Wiley is claiming Force Majeure, Wiley will be entitled to implement a reasonable alternative where practical under the circumstances and if its inability to perform continues for more than 30 days or it is inadvisable or commercially impractical to perform due to Force Majeure, Wiley may terminate the Agreement without penalty or charge, on written notice, and Wiley's performance will be fully excused.
- 10.3.a. In case of a termination as stated above, Wiley will refund the Customer for the applicable prepaid Open Access funds that have not yet been used, nor committed, for the publication of any article.
- 10.4. Any notice, request, statement or other communication to be given hereunder to any party must be in writing addressed to Wiley at the address on page one, attention Executive Vice President, and to the Customer's Agreement Administrator at the address on Schedule 1 or mailed or delivered to such other address as each party may designate by notice given in like manner, and any such notice, request, statement or other communication, will be deemed to have been given when received, except that if mailed by registered or certified mail, return receipt requested, or delivered by overnight courier service, it will be deemed to have been given when mailed as aforesaid or when delivered.
- 10.5. This Agreement constitutes the complete understanding of the parties and supersedes all prior understandings between the parties with respect to the subject matter of this Agreement. No modification, amendment, or waiver of any provisions will be valid unless in writing and executed by the parties. Any waiver in one or more instances by either of the parties of any breach by the other of any terms or provisions contained in this Agreement will not be considered a waiver of any succeeding or preceding breach. In the event that any paragraph of this Agreement is determined to be void or unenforceable, the remainder of the Agreement will survive.
- 10.6. In the event that this Agreement is executed in English and in a translated version, each party acknowledges that it has reviewed both language versions and that they are substantially the same

in all material respects. If there is any inconsistency between these two versions, the English language version will prevail.

11. **PUBLISHING PRIVILEGE**

- 11.1. Wiley hereby grants the Customer a discount of 5% on the APC for any Accepted Articles published by Corresponding Authors under the terms of this Agreement, subject to sufficient funds remaining available in the Customer's WOAA.
- 11.2. Wiley agrees to the open access publication in Hybrid and Gold Open Access Journals (<https://authorservices.wiley.com/author-resources/Journal-Authors/open-access/articlepublication-charges.html>) of Accepted Articles as requested by Corresponding Authors through the agreed workflow outlined below. The Customer agrees to pay the Advance Payment and any additional top-up payments. Corresponding Authors publishing under this Agreement and subject to the provisions of their author agreements grant Wiley the right to publish these articles under a Creative Commons license unless the Corresponding Author chooses to opt out of open access publishing.
- 11.3. This publishing privilege will commence for articles accepted from 1 January 2021 and end for articles accepted on 31 January 2021, subject to sufficient funds remaining available in the Customer's WOAA.
- 11.4. Wiley will provide workflows that offer open access publishing in Gold and Hybrid Open Journals at no additional cost to all eligible Corresponding Authors who provide to Wiley sufficient information for Wiley to establish the Corresponding Author's affiliation to the Customer in the manuscript submission system of the Journal, Publisher's Author Services system, or the Publisher's production system.
- 11.5. Under the standard hybrid publication workflow, if the Corresponding Author has identified their primary affiliation with the Customer, the Corresponding Author will choose whether to publish open access or subscription. The option to publish open access will be presented as default.
- 11.6. Wiley is authorized to collect payments under the Agreement both on its own behalf and on behalf of other Wiley group companies which own or publish the Hybrid and Gold Journals. In consideration of the Advance Payment (if applicable) and any other payments made by the Customer and subject to the terms and conditions of the Agreement. Wiley shall during the term of the Agreement:
 - 11.6.a. not charge Corresponding Authors APCs for any primary research or review article submitted by a Corresponding Author according to Wiley's WOAA workflow that is accepted for publication in a Hybrid or Gold Journal, provided that the Customer has sufficient funds in their WOAA to cover the APC;
 - 11.6.b. list the Customer on the Site as an Institutional Account Holder;
 - 11.6.c. provide a link from the entry for the Customer on the Institutional Account List on the Site to the Customer's Website.
- 11.7. Wiley shall be responsible for the identification of Corresponding Authors as part of the submission and publication process (for gold Open Access and hybrid journals respectively), and the Customer shall verify the eligibility of a Corresponding Author via the WOAA dashboard.

Corresponding Authors will be identified through at least one of the following parameters: their organization name; their e-mail domain; persistent identifier, such as Ringgold or other recognized institutional identifier. Wiley will notify the Customer via email and/or the WOAA dashboard (depending on how the Customer has configured the WOAA) each time an Author of an Accepted Article is identified as affiliated to the Customer and selects the option to publish his/her article as open access for both Hybrid and Gold Journals.

- 11.8. If Wiley fails to identify Corresponding Authors as eligible and then publishes their article on a subscription basis, Wiley shall be responsible to convert the article so that it is published open access. If Wiley fails to identify Corresponding Authors as eligible and then charges them for publication of their article, Wiley shall refund the author within 30 days.
- 11.9. If the Customer denies affiliation for a submission, the Corresponding Author will be offered the opportunity to pay the APC or to publish under subscription terms.
- 11.10. Wiley will report annually how many Wiley's journals have flipped during the year from/to a subscription model to/from an open access model, including hybrid model.
- 11.11. Editorial Independence. Nothing in this Agreement will oblige Wiley to publish any article submitted to Wiley by a Corresponding Author or the Customer. The Customer acknowledges that the selection of material to be published in the Hybrid or Gold Journals is entirely at the discretion of Wiley and/or the editors of the Hybrid or Gold Journals and the Customer waives any claim it may have against Wiley or its editors in the event that Wiley and/or its editors refuse or decline to publish any material (or part thereof) submitted by a Corresponding Author or the Customer. An article will be considered to be selected for publication once the Corresponding Author(s) has been notified that the article has been accepted and Wiley has received the applicable publishing agreement for the Hybrid or Gold Journal signed by the right holder(s) of the article.
- 11.12. Terms of Publication. Corresponding Authors publishing under this Agreement retain copyright and grant Wiley the right to publish these articles under a Creative Commons license. Eligible Authors will be able to select the Creative Commons Attribution license (CC-By), Creative Commons license Attribution Non-Commercial 4.0 International (CC-By-NC 4.0) or the Creative Commons license Attribution Non-Commercial Non-Derivative 4.0 International (CC-By-NC-ND 4.0) for the publishing of their articles if they wish.

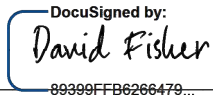

SCHEDULE 3 - OPEN ACCESS PUBLISHING FEES

Customer: Iowa State University

1. The annual payment made for the OA Fee will fund the Wiley Open Access Account balance to be managed by the Customer. The OA Fee is used on a first in, first out basis. The Customer may choose to provide additional fees to its WOOA at any time.
 - 1.1. APCs due for each Accepted Article are deducted from the OA Fund at the time when the Accepted Article has been accepted for publication, until such time as the OA Fund value has been reached.
 - 1.2. If the Customer is unable to spend the maximum OA allocation in the Fund, Wiley agrees to rollover up to a maximum 10% of the total year 1 OA allocation into year 2, adding the rollover value to the agreed maximum OA allocation. At the end of year 2, if the Customers are unable to spend the maximum OA allocation, Wiley agrees to rollover up to a maximum 5% of the revised year 2 OA allocation (including the rollover value) into year 3. There will be no rollover if there is underspend at the end of year 3.
2. APC charges for both Gold and Hybrid publications will be at APC list price for the journal with an agreed discount of 5% applied. This discount only applies to submissions using the pre-paid fund and any additional APC paid through additional deposits into the Wiley Open Access Account.

SCHEDULE 4 - INTERNET ACCESS AND SERVICE RELIABILITY

Our highly qualified Hosting Services staff is fully dedicated to serving the needs of Wiley Online Library customers. They meet on a frequent, regular basis to review performance and plan for maintenance and upgrades. Our Planning and Implementation Program includes continual dialog with our Development Team, Business Operations and Product Development Group to assess current and future requirements and review action plans for continuing to meet our commitment to our customers.

The results of these efforts speak for themselves. Wiley Online Library customers enjoy among the highest levels of performance dependability in the industry. Wiley Online Library has averaged over 99% uptime since its commercial launch in 2010.

In addition, we have detailed backup and recovery procedures and failover systems in place to minimize service interruption in the occurrence of a catastrophic event. Other best practices approaches used to manage our Internet hosting environment include redundant disk storage area networks with real-time replication to a second location, further protected with daily incremental and full weekly backups of all journal content. Our backups are performed using a Virtual Tape Library disk to disk backups with both onsite and offsite copies via daily replication. 1. **Archival Access:** During the term of this Agreement, Wiley will provide the Customer with access to current content published during the Agreement term in the journals in the Core Collection and retrospective content, generally back to 1997, depending on the start date of online publishing by Wiley, as well as tables of content, abstracts, full text and illustrations and any additional electronic journal content not included in the print versions of the journals, but not materials included in Backfiles.
2. **Perpetual Access:** Upon termination of this Agreement, Wiley will provide the Customer with perpetual access to current content published during the Agreement term in the journals in the Core Collection and retrospective content, generally back to 1997, depending on the start date of online publishing by Wiley, as well as tables of content, abstracts, full text and illustrations and any additional electronic journal content not included in the print versions of the journals, but not materials included in Backfiles where Wiley has the rights to deliver this.
3. **Electronic Journal Subscription Maintenance and Swapping:** The Customer may swap subscribed online journals in the Core Collection without penalty provided that such changes do not exceed 5% of the value of the total Core Collection for any calendar year. These changes will be reflected in amendments to this Appendix. Swapping will be accepted at the title level or for duplicate subscriptions. Swapping will only be accepted on a calendar year basis and Wiley must be notified of any changes in writing no later than the preceding November 1st. If a swapped subscription is not the only subscription to that Electronic Journal in the Customer's holdings, the Customer will continue to have electronic access to that Journal. If a swapped subscription is the only subscription to that Electronic Journal in the Customer's holdings, then the Customer will lose access to the newly published content of that title permanently.
 - 3.1. Wiley may, from time to time, cease publication of individual journals in which case the journal(s) will be removed from the Customer's Core Collection, and the fees associated with the journal(s) will no longer be factored into the Core Collection Fee.
 - 3.2. Except as provided above, the Customer must maintain all online subscriptions in the Core Collection as set forth in the attached list as Appendix B(a)1.
4. **New Titles:** New Titles can be added under the following terms and conditions:
 - 4.1. The Customer may add new journals to its Core Collection at the full rate institutional online only subscription price.
 - 4.2. Subscriptions to titles transferred into Wiley from another publisher will be added to the Customer's Core Collection in the first year of transfer if the Customer has one or more subscriptions for the calendar (or subscription) year in which the title is transferred. Individually negotiated fees for access to transferred titles will also be maintained by Wiley, subject to the other terms of this Agreement. Subscriptions to titles transferred out of Wiley will be deleted from the Customer's Core Collection in the year of transfer.
 - 4.3. The Customer may add previously canceled titles at the current full rate institutional online only subscription price to its Core Collection.
 - 4.4. Wiley reserves the right to exclude titles from inclusion in the Standard or Custom Collections, however these titles may be added to the Customer's Core Collection.
5. **Print Subscription Pricing:** The Customer can purchase print subscriptions to Licensed Electronic Journals which the Customer subscribes to via a Core Collection at a deeply discounted rate. This does not apply to:

- 5.1. Titles new to Wiley Online Library (or other platforms designated by Wiley) unless subscribed to in the Customer's Core Collection.
- 5.2. Titles not subscribed to by the Customer, unless added to the Customer's Core Collection.
- 5.3. Titles not available via Wiley Online Library.
- 5.4. Titles published in online-only format by Wiley. Print subscriptions available through any Print on Demand option are not eligible for a deeply discounted rate.
- 5.5. Print subscriptions should be ordered directly via the Wiley Customer Services department, or through an agent.
